September 2007 Minutes

The September meeting of Thresher Base was held at the Portsmouth VFW on September 15, 2007.

The meeting was called to order followed by a prayer and pledge of allegiance. The Tolling of the Bells was conducted for those boats lost in September and October. A sound off of all those present was conducted.

The secretary's report from July was read by Kevin Galeaz. The treasurer's report was read by Dennis O'keefe.

• Navy Memorial Dedication to be held on Sunday, September 23 at the Veteran's Cemetery in Boscowen - Gov. Lynch, Shipyard Commander and Silver Dolphins Rifle Team will be present.

• Also on September 23rd, Portsmouth will be holding a parade to mark the 102th anniversary of the Treaty of Portsmouth and labor unions. The shipyard labor union requested that the military join them in the parade, since they are an integral part of the shipyard. Command Master Chief Shoe will be the senior military representative.

• On September 10, PBS aired its season finale of History Detectives which featured a segment on the USS Thresher. In addition to interviewing Lori Arsenault, they showed footage of the base website which served as great PR, because Kevin Galeaz was contacted by National Geographic representatives who wish to produce a longer piece on the USS Thresher. Kevin put them in contact with Lori Arsenault and John Cook. Kevin feels that there may be many other opportunities upcoming because of the 45th anniversary of the loss. National Geographic is also looking for anyone who served on the USS Skylark.

• Website update - Photo sharing site setup to allow members to download photos. Photos of the 2006 and 2007 Lobsterbakes and 2007 Holland Club induction are available. Kevin Galeaz will continue to work on uploading photos from past events. John Carcioppolo suggesting sending a CD of all photos to USSVI archives.

• Subvets WWII next meeting will be October 20, noon at Newicks, Dover.

• Isle of Shoals cruise line offers tickets to veterans who are ill or disabled, and they will take care of all the arrangements. Contact Bill Tebo for more information.

• John Carcioppolo attended Admiral Fluckey's funeral and noted 22 subvets in attendance. He spoke with Admiral Konetzni who has taken on the lead of subvets WWII who have a combat patrol pin and a bronze star. He has asked the organization to send letters to the President of the United States, Chief of Naval Operations, Secretary of Defense, Fleet Reserve Association and VFW.

• John Carcioppolo has taken on a project of recognition of WWII submariners on the WWII Registry. He is specifically working on connecting the sailors on lost boats with the submarine community. He is working one boat at a time. He is requesting that all WWII subvets document their association with the community. Contact Kevin Galeaz and he will send along your information to John.

• 2008 is the 40th anniversary of the loss of the Scorpion. Information will be forth coming on events and services.

• Nominations are needed for Senior and Junior Vice Commander

positions. Tom Young has indicated an interest in holding the Senior Vice Commander position. Larry Oiler nominated Tom for the position. Kevin Galeaz indicated an interest in holding the Junior Vice Commander position. Gary Hildreth nominated Kevin for the position. Elections will be held at the November meeting. Discussion was then held that in fact, the elections were to be held at this meeting and the nominations were to be made at the July meeting. So voting was held on the two vacant positions - both positions were filled unanimously.

• Newsletter articles - write your biographies, tell us your stories, help will be provided if you need it. Especially the WWII vets who are a part of living history.

• Larry Oiler was presented with a plaque to recognize all the work that he has done for the base. He promises to be as active as possible.

• 45th Memorial Service will be held on Saturday, April 12, 2008. Kevin Galeaz is looking for people to help.

• A silent prayer was held and the meeting was adjourned.

The book is uniquely written in that his co-author (Flint Whitlock-author of some 8 other war books)tells the story of the submarine war in the Pacific but every other chapter is a chapter of Ron’s life and near death struggles in a WWII submarine.

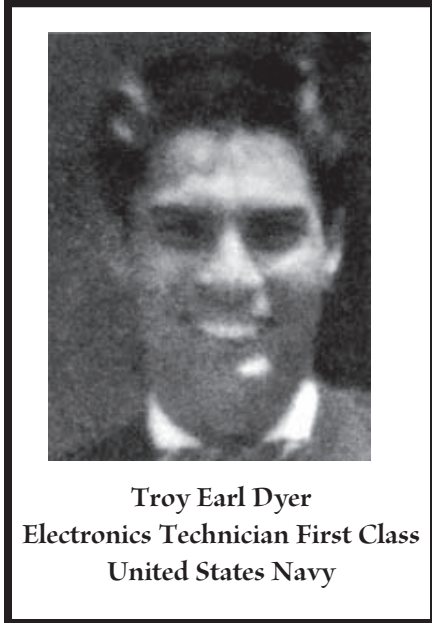
Ron is a member of SVWWII and USSVI.



To Perpetuate the Memory



Troy Earl Dyer was born on January 20, 1933, in Greenfield, Okla. He enlisted in the Navy on August 1, 1950, in Oklahoma City, Okla. He received his basic training at the U.S. Naval Training Center, San Diego, Calif., and had his first tour of sea duty in the destroyer U.S.S. Duncan (DD 874). He also served in the minesweeper U.S.S. Loyalty (AM 457), and on the staff of the com-



mander, Mine Squadron 9.

Troy had earned the navy's Good Conduct Medal, the Korean Service Medal, China Service Medal, National Defense Service Medal, and the United Nations Service Medal, for service during the Korean conflict.

He volunteered for submarine duty and upon being accepted, he was enrolled as a student in the Navy's Submarine School located at the U.S.

Naval Submarine Base, New London, Conn. He successfully completed the course of instruction and was assigned to the submarine U.S.S. Sea Cat (SS 399), in March 1959.

Troy was qualified as a submariner while serving in the Sea Cat, and was awarded the silver dolphins; the insignia of the qualified submariner.

On February 27, 1961, Troy was assigned to the nuclear-powered submarine U.S.S. Thresher (SSN 593).

He is survived by his widow, Mrs. Ginger Dyer, and three children, Stephanie, Stephen, and Troy D. of San Diego, Calif.

Ellwood Henry Forni was born on October 28, 1928, in Baltimore, Md. He attended local public schools there, and enlisted in the Navy on May 21, 1948. During his recruit training at the U.S. Naval Training Center, Great Lakes, Ill., he volunteered for submarine duty and reported to the Submarine School at the U.S. Naval Submarine Base, New London, Conn., in August, 1948.

Successfully completing the course of instruction, he was assigned to his first Submarine, the U.S.S. Sennett (SS 408). It was while serving in Sennett that Ellwood became qualified as a submariner and received his silver dolphins. He then attended the Navy's Fleet Sonar School at Key West, Fla., and after graduation, he was assigned to the U.S.S. Sea Cat (SS 399).

Service in the submarines U.S.S. Quillback (SS 424), U.S.S. Guavina (SS 362) and U.S.S. Sea Poacher (SS

406), followed until October, 1959. He was then selected for training at the Guided Missile School, Dan Neck, Va.

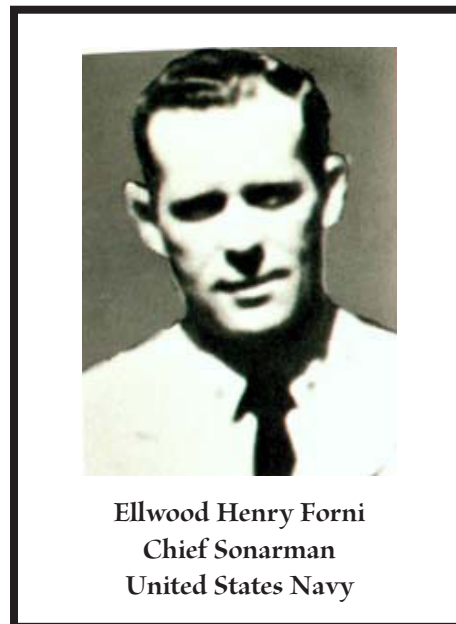
After this training, Ellwood was assigned to the nuclear-powered submarine U.S.S. Tullibee (SSN 597), where he received a letter of commendation from the commander, Submarine Force, U.S. Atlantic Fleet, for his outstanding assistance and performance of duty during the "in-service trials" of the U.S.S. Tullibee.

He had also earned the Navy's Good Conduct Medal with four

stars; National Defense Service Medal, a letter of commendation from the commanding officer of the U.S.S. Thresher (SSN 593) and a letter of commendation from the commander, Submarine Force, U.S. Atlantic Fleet.

On August 4, 1961, Ellwood was assigned to the U.S.S. Thresher.

He is survived by his widow, Mrs. Mildred M. Forni of Mystic, Connecticut; his parents, Mr. and Mrs. Edmund F. Forni, Sr., and a brother, Edmund, Jr., all of Pikesville, Maryland.
